14 ACTING CHAIR KURYLOWICZ: Okay, so we're out of
15 closed session.

16 Thanks for coming back and for sticking around. I
17 know you guys had far to go, so...

18 So just to let you know, that the Commission has
19 interviewed the candidates for executive director, and is
20 taking action to tentatively select one of the candidates
21 who would go forward in the selection process by having a
22 background investigation.

23 The commissioners have agreed to allow the executive
24 director subcommittee to review the results of the
25 background investigation and formally approve the
