Regulation 1011

At the June 26, 2014 meeting, the Commission approved proposed amendments to the POST Administrative Manual (PAM), Section B – Regulation 1011 Certificates.

POST is proposing changes to expand Regulation 1011(c)(6) to include Dispatcher Supervisory Certificate Award Requirements and update Regulation 1011 for corrections to non-substantive errors and language.

Justification for Proposed Revisions

In 1989, at the October Commission Meeting, a Public Safety Dispatcher Certificate Program was introduced as researched by Darrell Stewart. Testimony on the proposal was received at the following Commission Meeting in January 1990. In April 1990, after testimony and discussion, the Commission unanimously adopted the program, effective July 1, 1990.

In September 2006, a proposal was made to establish intermediate and advanced professional certificates for dispatchers. This proposal was approved by Executive Director Kenneth O'Brien in October 2006 and included a continued professional training requirement of 24 hours every 24 months.

In 2010, it was determined that a Dispatcher Supervisor Course was warranted. This course was developed and implemented in 2011, through the South Bay Regional Public Safety Training Consortium. In 2013, Golden West College started hosting the class in southern California.

In January 2013, POST contracted with Special Consultant Rosanna McKinney, to develop and support the POST Public Safety Dispatcher Program, including the Dispatcher Supervisor Program. Ms. McKinney discussed the concept of a Dispatcher Supervisory Certificate with the Public Safety Dispatcher Advisory Committee (PSDAC). The PSDAC approved the concept of a Dispatcher Supervisory Certificate, to be included in the POST Professional Certificate Program in March 2013.

In May 2013, staff presented a proposal to the Training Program Services Bureau Chief and to the POST Leadership Team, respectively, to gain consensus on establishing the Dispatcher Supervisory Certificate. The concept was well received and it was determined that the proposal should move forward for Commission approval. It was also decided that an update to the regulation was warranted.

Criteria standards for a Dispatcher Supervisory Certificate are designed to provide a benchmark to assure agencies that the person selected has received training to POST standards and demonstrated proficiency by completing a probationary period. While there are a number of POST-certified supervisor courses available, a specific dispatch supervisor course was established by South Bay Regional Public Safety Training Consortium and was first offered in February 2011. It is specifically designed for the dynamic and fluid environment of a communications center. The course is now offered in both northern and southern California and aids in enhancing the level of professionalism for public safety dispatchers and supervisors. It has been exceptionally well received and offers dispatch supervisors a variety of skill sets in leadership, ethics, and conflict management similar to those in the sworn supervisor courses. Attainment of the Dispatcher Supervisory Certificate will be partly predicated on completion of a POST-certified supervisory course or the Dispatcher Supervisor Course.

Justification for Amendments to Regulation 1011 Certificates

Regulation 1011. Certificates.

[1011(a) through 1011(a)(1)]

Regulation 1011(a)(1)(A) changed “distinguished” to “distinct” to reflect proper grammar.

(A) The Commission-awarded certificate is a “professional” certificate pursuant to Penal Code (PC) section 13510.1, and is ~~distinguished~~ distinct from a “certificate of completion” which is awarded by a training presenter when an individual successfully completes a course.

Throughout Regulation 1011 education “points” have been changed to education “units” to correctly reflect the manner in which college credits are measured. This change also maintains consistency in verbiage on POST forms 2-116 Certificate Application, 2-117 Certificate Application – Record Supervisor, 2-250 Request for Reissuance of POST Certificate, and 2-289 Certificate Application – Public Safety Dispatcher.

(B) Education ~~Points~~ Units

For purposes of certificate qualifications:

1. One college semester unit equals one education ~~point~~ unit, or
2. One college quarter unit equals two-thirds of an education ~~point~~ unit.

(C) Training Points

For purposes of certificate qualifications:

1. Twenty (20) hours of **law enforcement** training are equal to one training point. Only completed courses with verifiable hours are accepted.
2. The Commission shall determine acceptable law enforcement training.

(D) Education ~~Point~~ Unit Conversions

When education ~~points~~ units exceed the number needed to qualify for a certificate, the excess education ~~points~~ units may be converted to training points to meet training point requirements. One education ~~point~~ unit shall equal one training point. POST will make the conversion when it is to the advantage of the applicant.

(E) Law Enforcement Experience

Law enforcement experience described in 1. below is accepted if it is recorded on the POST Profile in the POST database. POST may accept the experience described in

(5) Basic Certificate Possession Requirement

The Basic Certificate is required for:

(A) Specified Peace Officers

Pursuant to Penal Code section 832.4(b), every peace officer listed in Penal Code section 830.1(a) [except a sheriff, an elected marshal, or a custodial deputy appointed pursuant to Penal Code section 830.1(c)] shall obtain the POST Basic Certificate **in order to continue to exercise peace officer powers**. PC 832.4 requires possession upon completion of probation, but in no case later than 24 months after appointment. However, if the department's probation period is 24 months, an additional ~~3~~ three months is authorized.

Business Impact/Small Businesses

The Commission has made an initial determination that this regulatory proposal would have no significant statewide adverse economic impact directly affecting California businesses, including the ability of California businesses to compete with businesses in other states. The proposal does not affect small businesses, as defined by Government Code section 11342.610, because the Commission sets selection and training standards for law enforcement and does not have an impact on California businesses, including small businesses.

Cost Impacts on Representative Private Persons or Businesses

The Commission on Peace Officer Standards and Training is not aware of any cost impacts that a representative private person or business would necessarily incur in reasonable compliance with this proposed action.

Assessment

The adoption of the proposed regulation amendments will neither create nor eliminate jobs in the State of California and will not result in the elimination of existing businesses or create or expand businesses in the State of California.

Consideration of Alternatives
