The All Committees Conference of the Peace Officers of the State of California is held in conjunction with the general call of the Attorney General for the All Zone Meeting of Chiefs of Police and All Zone Meeting of Sheriffs. The Commission was introduced to all those attending the All Committees Conference.

Chairman Ficklin reported to the Commission the succession of events pertaining to the recruitment of the Executive Secretary. Written reports had previously been supplied the Commissioners.

Motion duly made by McDonnell, seconded by Andersen, that the Commission continue its efforts to establish a salary range for its Executive Secretary position having a minimum salary of not less than \$12,000 per annum. Motion unanimously carried.

Extensive discussion was had concerning the number of applicants for the Executive Secretary position, the relative merits, and the current salaries of the applicants.

Motion duly made by Commissioner Campen, seconded by Commissioner McDonnell, to suspend consideration of applicants for the position until the salary matter is settled. Motion unanimously carried.

Attorney General Stanley Mosk joined the Commission meeting and was informed of the complications regarding a salary range for the Executive Secretary position. The Attorney General agreed to pursue the matter, either by further discussion of the subject with John Carr, Director of Finance, or, Governor Edmund G. Brown, or both, and, if necessary, to ask members of the Commission to join with him in a conference with the Governor on the subject.

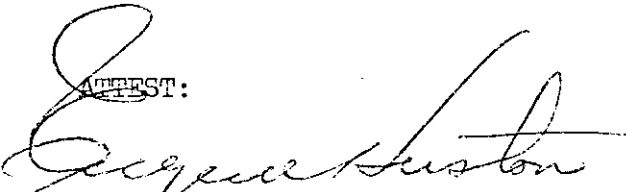
Applications for the Executive Secretary position were received from thirteen (13) candidates as follows:
