A. <u>Public Hearing on Proposed Amendment of Regulation 1002 (a)(2)</u>, Minimum Standards for Employment

In accordance with the Administrative Code procedure the Chairman opened the hearing, the Executive Director presented all exhibits of compliance and read all testimony into the record. Discussion was heard and written testimony presented on the advisability of inserting the words "in any foreign government" to the proposed amendment. No testimony was presented from the floor. There was concurrence that inasmuch as the foreign government phrase had not posed a problem in the past, the following motion was made:

Of the 157 course categories, 32 (20%) were not presented during the year. Sixteen (10%) were presented once, and seventeen (10%) were presented twice.

Number of Trainees:

In F.Y. 74-75, 13,304 attended POST-approved courses. This was a 35% decrease from the 20,620 trainees in 73-74, and occurred mainly in the Advanced Officer and Technical Special Courses.

D. Contracts and Certificates, F.Y. 1974-75 Reports

Contracts

Mr. Toothman presented the following report in compliance with the Commission policy adopted at the January 23-24, 1975 Commission meeting which requires that "once each year there will be a report to the Commission which enumerates the contracts and interagency agreements entered into during the year, and the status of each showing the amount of money encumbered for contracts".

State Controller - To provide field audit services 1-P \$ 30,000 92-P CSU, Long Beach - POST paid \$7,852 for work performed on a course, "Law Enforcement Training Management Course." 7,852.45 21-P Alan E. Ellis - To develop, coordinate and supervise the presentation of a "Sheriff's Orientation Course." 10,997.76 ·90-P Golden Gate University - To arrange and conduct two presentations for POST of course entitled, "Law Enforcement Training Management Course." Contract was for \$22,696. Completed at a cost of \$21,362.47 21,362.47 28-P Los Angeles Police Department - Contract was developed for a Minority Recruitment Program in the amount of \$28,663. Contract voided for lack of signature by L. A. P. D. 14-P State Personnel Board - Contract was made in the 1973-74 F.Y. for a total of \$206,420. The total was encumbered and paid out of F.Y. 73-74 except a balance of \$51,605, which is being held for completion of the contract. In August 1974 an additional \$7,790 was encumbered during the current fiscal year for payment of special legal costs by the Attorney 7,790. General's Office. This amount has not yet been paid. Thomas H. Anderson - To develop an Executive Development 67-P 1 Course and to coordinate four presentations of the course. The total amount of the contract was \$31,870 of which \$6,450 was encumbered for F.Y. 74-75 and the remaining 6,450 \$25,420 encumbered in F.Y. 75-76. Department of Justice/POST Interagency Agreement - To conduct 118,704.87 training courses.

Certificates Report, F.Y. 1974-75

<u>General Certificates</u>: It was reported by Mr. Toothman that the number of POST Professional Certificates issued during each of the last four years has remained relatively stable. However, there has been a gradual decline of Basic Certificates and an increase in the number of Intermediate and Advanced. A chart was presented which showed the experience since the program started; it is set forth as Attachment B.1.

Two hundred two Management Certificates were issued in 1974-75, which was a slight increase over previous years, while the Executive Certificates have steadily declined with only 14 issued during 1974-75.

<u>Specialized Certificates:</u> The issuance of Specialized Basic, Intermediate and Advanced Certificates has remained relatively steady for the past three years, averaging over 800 per year.

A chart showing certificates awarded by year and certificate type since January 1964 to present is set forth as Attachment B.2.

E. Report on 1975-76 Budget

Mr. Toothman reported on the following actions taken on the POST 1975-76 Budget since the April 24-25 Commission meeting:

Action by the Joint Legislative Budget Committee: The Joint Legislative Budget Committee approved the recommendations made by the Senate Finance Budget Subcommittee and the Assembly Ways and Means Budget Subcommittee, as follows:

Standards and Training Division conduct an in-depth review of the course content of all Supervisory and Middle Management courses and seminars to ascertain their relevance and applicability to the functional needs of police officers, and report thereon to the Joint Legislative Budget Committee by June 30, 1976.

One Law Enforcement Consultant II added for one year to Standards and Training Division to carry out the project. (Cost - \$25,200)

One Senior Law Enforcement Consultant, one Law Enforcement Consultant II, one Senior Stenographer and one Clerk Typist to be approved for the Standards and Training Division to sustain ongoing workload. (Cost - \$89,747)

In conformance with an agreement with POST and the Department of Finance, the Joint Legislative Budget Committee approved the

present status quo of personnel in the Administrative Counseling Division, which is to remain unchanged for the 1975-76 F.Y. with the stipulation that the POST Advisory Committee make a study of the Division and the Commission submit a report to the Joint Legislative Budget Committee by December 15, 1975.

<u>Governor's Action on Budget, June 30, 1975</u>: In the Governor's review of the budget prior to signing it, he took the following action:

Approved one position of consultant for the Standards and Training Division to conduct study of Supervisory and Middle Management Courses. (Allocated \$25,200)

Denied funds for the addition of two consultants and two clerical positions for the Standards and Training Division. (Reduced budget by \$89,747)

Action on Federally Funded Grant Projects: The two federally funded grant projects: Center for Poll o Management and Crime Prevention Institute, which are under the direction of the Technical Services Division, were disapproved by OCJP for 1975-76 F.Y. funding. Inasmuch as both projects

were ongoing, the Commission, at its June 13 meeting, approved allocation from the P.O.T.F. for continuation of the programs for the current year. The Department of Finance concurred in this action.

The Center for Police Management program is funded for \$98,243. Carryover grant monies from the previous fiscal year are sufficient to fund the project for the months of July and August.

The Crime Prevention Institute program is funded for \$67,502 from the P.O.T.F.

The amount of \$165,745 for the two projects is added to the total of POST Administrative Costs.

F. Reimbursement Plans - Status Report

The Executive Director reported that although at the April 24th meeting the Commission adopted a new reimbursement plan which would increase reimbursement to city and counties for F.Y. 75-76 from a total of \$9.1 million to \$14.8 million, the Department of Finance has stated the earliest consideration could be made for a decision on the reimbursement plans would be January of 1976...All reimbursement plans will remain status quo until that time. This information has been forwarded to the field in POST Bulletin 75-4.

G. Certification of Courses

Commissioner Anthony requested that Agenda Item #58 regarding a moratorium on course certifications be addressed prior to the complete Course Certification Agenda. There was discussion of the staff recommendations, which were:

- 1. Effective August 1, 1975, there be declared a moratorium on certification of new courses.
- 2. Staff develop a master training plan to emphasize needs, assessment, and job specific training requirements.
- 3. After adoption of the above as a long-range planning document, certify those courses initiated by staff to meet identified training needs.
- 4. Staff-initiated certification requests shall emphasize the Commission policy of increasing regional training while relying on local agencies for continuing identification of training needs.

Following discussion, the following amended motion was passed:

recommendations, effective subsequent to this date:

- Effective August 1, 1975, there be declared a moratoria on the certification of new courses. If it is found that a course is needed on an emergency basis, it may be brought before the Commission.
- Staff is to develop a master training plan to emphasize needs, assessment, and job specific training requirements.

Further, within six months (January 1976 Commission meeting) staff shall present a status report to the Commission outlining the progress made on the master training plan and an indication of the time frame within which the adopted recommendation can be completed.

59. Baton Training for Private Security

MOTION by Commissioner McCauley, seconded by Barton, carried unanimously for adoption of the Baton Training Course outline prepared to meet the requirements of legislation, effective January 1, 1975 (S.B. 1740).

Commissioner Collins requested item B. 4. of the Course Outline entitled "Offensive Techniques" be titled "Control Techniques." There was consensus, and it was so ordered.

Reimbursement Considerations - Technical Courses, Per Diem and Mileage

1. Mr. Townsend requested that staff be given administrative authority to implement the reimbursement of certain Technical Courses, as had been approved by the Commission at the April 24, 1975, Commission meeting, under Plan III. The direction that had been given by the Department of Finance regarding reimbursement was that salary reimbursement remain at 60%, but the reimbursement of tuition had not been addressed by Finance.

Mr. Ellingwood stated there are no legal problems with adhering to this pay plan for tuition -- this was a policy which the Commission had previously approved.

It was the consensus of the Commission that certain Technical Courses, as approved by the Commission, shall be reimbursed under Plan III, effective August 1, 1975, since funds had been committed by the Commission in the current budget.

Discussion was called regarding the action taken by the Commission at the April 24, 1975, Commission meeting that would change the amount of per diem reimbursed from \$24 to \$30, and the mileage rate from 10¢ to 15¢ per mile. Following discussion the action was amended as follows:

> MOTION by Commissioner Anthony, seconded by Enoch, carried unanimously that effective August 1, 1975, per diem and mileage allowances for out-of-pocket travel expenses will be based on the maximum amount allowed under the State Board of Control rules.

Mr. John Smock, lobbyist for the Judicial Council, addressed the Commission in support of S.B. 189, Vehicle Offenses: Mailed Bail Deposits.

The meeting was recessed at 5 p.m. until 9 a.m., August 1.

Reconvene:

The meeting was reconvened on August 1 at 9 a.m. by Chairman Barrett. Attendance was as reported on July 31 with the exception of Sheriff Brad Gates, Advisory Committee Member, who was absent.

H. Instructional Costs and Tuition Policies

In response to a request from Commissioner Collins at the April 24-25, 1975 Commission meeting that staff review the problem of variances in instructor costs up to the \$50 allowed in the Guidelines, and the problems Los Angeles Police Department experiences in not being paid instructional costs, the Executive Director reported the research work to study the issues had been assigned. A complete report will be made at a future Commission meeting.

I. Crime Prevention Program

Mr. Koch reported that the F.Y. 1975/76 budget augmentation to provide two positions for the Crime Prevention Institute was approved by the Commission at the June 13 meeting. Because authorization for two additional positions originally authorized in the grant was turned down at the June 28 C.C.C.J. meeting, staff requested approval of the Department of Finance recommendation that one consultant be employed and that the amount of \$29,484 be included in the F.Y. 1975/76 budget for this purpose.

> MOTION by Commissioner Collins, seconded by Anthony, carried unanimously that one Consultant I position be approved for the Crime Prevention Program for F.Y. 75/76 and that an expenditure of \$29,484 be authorized to support this position, effective August 1, 1975.

J. <u>Proposed Regulation and PAM Changes</u>

Mr. Koch referred to the action taken at the June 13 Commission meeting that approved changes in the POST Regulations as determined by the Selection Validation Study, and approval was requested of the following

proposed changes to be placed on a future public hearing agenda.

MOTION by Commissioner Enoch, seconded by Collins, carried unanimously that the following proposed Regulation changes be included on the next public hearing agenda of October 23, 1975, and PAM Section C-3 be amended as proposed.

Amend Section 1002 (a)(6)

Be interviewed personally prior to employment by the department head or his representative(s), to determine his suitability for the police service including such things as the recruit's appearance, personality, maturity, temperament, background and ability to communicate. This regulation may be satisfied by a member of the law enforcement agency participating as a member of the oral interview panel.

Add <u>Section 1002 (a)(8)</u>

Be able to read and write at the level necessary to perform the job of a peace officer as determined by passing "professionally developed" * examinations designed to test these skills.

* "Professionally developed" as interpreted in EEOC guidelines.

Amend Section 1002 (b)

To insure that every officer is fully aware of his individual responsibility to maintain his own integrity and that of his agency, every officer, during his basic training, shall be administered the Law Enforcement Code of Ethics as an oath as prescribed in Section 1013 of the Regulations. Reference to religious affirmation may be omitted where objected to by the officer.

K. Proposed Selection Standards Research Projects

a. Personal History Questionnaire and Investigator's Manual

Mr. Koch stated that although substantial information was presented in the Selection Standards Project of the Validation Study, there was a lack of definitive information to assist law enforcement agencies to utilize the findings of the report. Due to the expressed need from the field of a Personal History Questionnaire and comprehensive POST Personnel Investigator's Manual, and in answer to a recent court decision (Arnold vs. Ballard) which requires agencies to state in writing the policy of the agency for rejecting applicants on the background investigation, Mr. Koch presented a funding request for a Background Investigation Project.

The objectives of the project are as follows:

- 1. To revise the POST History Questionnaire
 - a. Revise according to court decision and EEOC requirements to eliminate non-job related questions.
 - b. Provide introductory information to the questionnaire to explain to the users the purpose and use of the information.
 - c. Document the purpose for specific inquiries of the questionnaire.
 - d. Provide necessary information to jurisdictions on the jobrelatedness of the background investigation for litigation purposes or compliance inquiries.
- 2. To revise and update the POST Personnel Investigator's Manual
 - a. Update the manual and incorporate it into the POST Administrative Manual and disseminate to law enforcement agencies.
 - b. Update and review all waivers to reflect recent changes.
 - c. List specific disqualifiers.
 - d. Develop a comprehensive checklist to be followed by law enforcement agencies.
 - e. Include a proper review process.
 - f. Provide examples of good narrative reports.
 - g. Provide suggested format and filing procedures.
 - h. Provide legal information on confidentiality of the background investigation.
- 3. Development of a prototype Background Investigator's Course.
 - a. Develop course content length, certification and development of instructional materials.
 - b. Involve those who wish to produce the course and gather input.
 - c. Present the course and revise after critique.
 - d. After making necessary revisions, present as a certified course.

Selection Standards Research Projects - cont.

Mr. Koch reported the project will take approximately one year at a cost of \$31,789. Manpower and cost breakdown as follows:

MOTION by Commissioner Stroh, seconded by Barton, carried unanimously for approval of \$31,789 to conduct the Personal History Questionnaire and Investigator's Manual Projects.

b. Medical Examination Validation

Mr. Freeman stated that although POST has a regulation requiring a medical examination and recommends use of POST Form 2-227, Medical Examination Report, it does not provide agencies with guidance as to what the medical examination should cover nor provide validation evidence as to the job-relatedness of the examination or the recommended form. The Selection Study did not address the validation of the medical examination.

The following three objectives of the proposed Medical Examination Validation Project were presented:

- 1. Establish a validated process by which agencies can determine the job-relatedness of physical conditions of peace officer applicants.
- 2. Identify in general terms job-related areas of the medical examination.
- 3. Identify specific disqualifiers within the major identified medical areas.

It was further stated that the project will take approximately one year at a cost of \$82,407. Manpower and cost breakdown were outlined as follows:

MOTION by Commissioner Ellingwood, seconded by Collins, motion carried (Nays - Anthony and McCauley) for approval of funding in the amount of \$82,407 to complete the Medical Examination Validation Project with the stipulation requested by Mr. Ellingwood that there be continuous liaison with the Attorney General's Office for legal advice and counseling during the study.

L. Advisory Committee Report - Mission, Goals and Objectives Study

22

Chairman Lance reported that the Advisory Committee had met on four occasions on the Mission, Goals and Objectives Study. It was explained that due to a change in the Committee membership, the study has been slowed down somewhat. Two-day sessions had proven to be helpful in working on the two assignments -- Mission and Goals study and the Administrative Counseling study.

The second interim status report on the review of the Mission, Goals and Objectives was mailed to the Commission On July 2, 1975. Included was the following statement which was adopted by the Advisory Committee June 19, 1975.

MISSION OF POST

To increase the effectiveness of California Law Enforcement.

Goals of POST

- 1. Establish minimum standards and guidelines for the selection of law enforcement personnel.
- 2. Establish minimum standards and guidelines for the training of law enforcement personnel.
- 3. Establish and maintain quality training courses designed to meet the needs of law enforcement personnel.
- 4. Assure adherence by participating agencies to minimum standards of selection and training by law enforcement personnel.
- 5. Improve management operational practices in law enforcement agencies.
- 6. Serve as a resource center for law enforcement research.

Commissioner Stroh questioned the meaning of statement number 6. Chairman Lance responded that gathered input indicated that law enforcement in California looks, not so much for the research work but, for a focal point where information is available regarding what is going on in law enforcement. Agencies are looking to POST for this guidance.

The Executive Director suggested that perhaps this statement could be reworded for clarification of the function of the Management Center.

It was reported that some questions being addressed in the Administrative

Advisory Committee Report - cont.

Counseling study are:

- Why is there a POST; is it necessary; is there a better way to use the money?
- Why is there an administrative counseling function in POST?
- Could Administrative Counseling and Standards and Training Divisions be combined?

Chairman Lance stated that at this time the Advisory Committee feels very strongly about supporting the Administrative Counseling function. The final report of the study will be presented to the Commission at the October Commission meeting.

The Executive Director commended the Advisory Committee on the fine job being done on the study.

M. Administrative Counseling Committee Report

Commissioner Barton, Chairman of the Administrative Counseling Committee, reported that the Committee had met on three occasions since given the charge of identifying the five areas of concern of the Committee, which were:

- 1. What is the function of the Administrative Counseling Division.
- 2. Should there be a charge for administrative counseling services.
- 3. Is there a proper role for the sharing of funds with private consultants.
- 4. Are we able to respond quickly enough to field requests.
- 5. Should POST be in the administrative counseling business at all.

These concerns had been resolved; however, they cannot be finalized until the full report is presented to the Commission in October. He further stated there were some specific recommendations to be coordinated with the Advisory Committee and, therefore, requested a joint meeting of the two Committees. It was agreed that the Administrative Counseling Committee will meet jointly with the Advisory Committee September 3 in Sacramento.

Commissioner Enoch felt that future requests for general surveys should be held in abeyance until such time as a Commission decision is made with regard to continuing this service, and the field should be so notified.

There was Commission concurrence.

Mr. Saltenberger stated that, based on the Commission's direction in October 1974, Administrative Counseling is not committing itself to providing general surveys upon initial request. The type of service

Administrative Counseling - cont.

rendered is not made until after the evaluation process is completed.

In response to Commissioner McCauley's question as to the length of time needed to complete the general surveys for which there had been commitments, Mr. Saltenberger stated 20 general survey commitments are pending which would entail a workload of 11 1/3 consulting man years and 3 1/2 support staff years. If the staff of 14 consultants worked exclusively on general surveys, these could be completed in approximately one year. It was stressed that Administrative Counseling is responding to many demands for management counseling services other than general surveys.

N. Legislative Report

William Keiser, Legislative Advocate, League of California Cities, addressed the Commission in opposition of S.B. 189, Vehicle Offenses: Mailed Bail Deposits.

The Legislative Report on S. B. 189 is presented as Attachment "C".

There was no discussion nor action taken on legislative matters with the exception of S. B. 189. The following action was taken on this bill:

MOTION by Commissioner Enoch, seconded by Collins, carried unanimously that the Commission take a neutral position on this bill.

O. Policy on Presentation of Special Awards

This item was set forward to a future meeting.

P. Old/New Business

Mr. Townsend reported on two informational items relative to participation in the POST program:

1. The city of Isleton joined the program effective May 12, 1975, and the city of Calexico effective August 15, 1975. The cities of Tulelake and Etna are going through the process of developing ordinances for participation in the program. The city of Ferndale has advised that their ordinance will be passed in the near future. With the passage of these ordinances, non-participation will be three jurisdictions: Fort Jones in Siskiyou County, and the cities of Imperial and Westmorland in Imperial County, employing a total of 20 personnel.

Commission Minutes

Old/New Business - cont.

 Following the certification action of July 31, total certified courses now equals 430. During the past 18 months, only 55 new courses have been certified, 105 courses have been modified, and 185 courses have been decertified. The review of courses will continue.

Q. Next Commission Meeting/Hearing

The next Commission Meeting and Public Hearing on Regulation changes will be October 23-24 in Sacramento. Exact location will be announced at a later date.

R. Adjournment

In memory of John Fabbri, Chief of Police of Fremont, who passed away on June 29, the following motion was made:

> MOTION by Commissioner Anthony, seconded by Enoch, carried unanimously that the meeting be adjourned in memory of John Fabbri who served on the Commission from 1966 through 1974.

There being no further business, the meeting was adjourned at 12:15 p.m.

SB 189 - Roberti - Vehicle Offenses: Mailed Bail Deposits

Judicial Council Report

The following information was offered by the Judicial Council regarding the pros and cons of SB 189.

In Support

- 86% conviction on all traffic citations in California.
- In each case where the penalty assessment was increased, fines flattened for a year after penalty assessments were raised, then the fines also raised drastically.
- There was a 5.5% average increase over each two years preceeding the year the penalty assessment was raised.
 - This was illustrated on a graph by the Judicial Council covering over 20 years to the present date.
 - The drastic increase in fines after the penalty assessment is increased is a deliberate move on the court's part to see that the revenues are generated according to legislative intent.
 - There is no indication that the courts will change that philosophy in the present situation.
- Presently, there is a recommended uniform bail schedule in the statute.
 - Courts are obligated to report any deviation they make from this schedule.
- San Mateo and Sacramento Counties have already raised bail schedules to include the penalty assessment and it has caused a great revenue increase.
- \$19.69 is the average fine for 1973/74 fiscal year, therefore, now is a perfect time to make a change.
- At the upper end of the bail schedule, the present fines are: 50 100 250.

- On a \$250 fine, the penalty assessment is \$65.
- On the proposed increase in the upper end of the bail schedule, a \$300 fine would amount to a \$60 penalty assessment taken from the fine.
 - This is the only case of a reduction.
 - In all other cases, an increase is noted in revenue or its status quo.

In Opposition

- 22 million could be lost by cities and counties if the bail schedules are not raised.
- Bail schedules cannot be mandated by legislation.
- CHP is opposed because of the difficulty in indicating the bail on the citation at the time it is issued as suggested by the Judicial Council.
 - SB 189 is presently on the Senate Floor by agreement of the author, until something is worked out with the peace officers in opposition.

Certificates Report F.Y. 1974-75

Mr. Toothman reported the number of professional certificates issued during the last four years has remained relatively stable at app. 8,000 yearly. However, there has been a decline of Basic and an increase in Intermediate and Advanced.

202 Management Certificates were issued in '74-75, which was a slight increase over previous $y \ge ars$, while the Executive Certificates have declined with only 14 being issued during '74-75.

Issuance of Specialized certificates has remained relatively steady at an average of over 800 per year.

To date, there have been 65,418 certificates issued in the Regular Program and 4,691 in the Specialized, totaling 70,109.

E. Budget Report

Mr. Toothman reported that in the Governor's review of the budget prior to signing it, he took the following action:

Approved one position of consultant for the Standards and Training Division to conduct study of Supervisory and Middle Management Courses. (Allocated \$25,200)

Denied funds for the addition of two consultants and two clerical positions for the Standards and Training Division. (Reduced budget by \$89,747)

Action on Federally Funded Grant Projects:

Center for Police Management project is funded for \$98,243. Carryover grant monies from the previous fiscal year are sufficient to fund the project for the months of July and August. Crime Prevention Institute is funded for \$67,502. The program will terminate as of June 30, 1976.

The amount of \$165,745 for the two projects is added to the total of POST administrative costs.

F. Reimbursement Plans

The Executive Director reported that the reibursement plans were status quo as stated in the June 27, 1975, Bulletin 75-4. The Department of Finance has stated the earliest consideration could be made for any change in the reimbursement plan would be January of 1976. He also reported that information had been received, indirectly, that the Department of Finance, in the very near future, will begin a management audit of POST.

The following shows the present status of all bills of interest to the Commission, that we are aware of, at the beginning of the 1975/76 legislativerecess and staff recommendations regarding each.

AB 251 - Department of Justice: Law Enforcement Total Service Project.

Would create in the Department of Justice a Law Enforcement Total Service 200 eres and the program. The service and the servic

AB 633 - Discrimination in Employment

Could permit homosexuals to become police officers.
